At Mind The Path Ltd, accessible from www.mindthepath.com, one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by Mind The Path Ltd and how we use it.

Credit Cards: We do not store credit card details. Payments for retreats are to be made by bank transfer on approval of application.

Mailing List: Here at Mind the Path Ltd we're very aware of the need to respect fully your privacy. When you book an event with us, we will ask for your name and email address. This is so we can administrate your booking and get in touch with you if needed for assessment. We will never pass on your details to any third parties. If you would like to sign up to our mailing list, to receive monthly newsletters by email, and emails promoting upcoming events, then you can opt-in to that separately.

Unsubscribing & Deleting Your Details: If you are signed up to our mailing list and would like to unsubscribe, you can do this by clicking on the link at the bottom of each email we send out, or by emailing the office at info@mindthepath.com. If you would like to have all of your details deleted from our database then please email the booking office at info@mindthepath.com and let us know. We will process your request within two weeks.

Photos: When pictures are taken at events, we inform participants to let the office know if they do not want their picture used in any Mind the Path or associate publicity material.

General Data Protection Regulation (GDPR)

We are a Data Controller of your information.

Mind The Path Ltd legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal

Information we collect and the specific context in which we collect the information:

- Mind The Path Ltd needs to perform a contract with you
- You have given Mind The Path Ltd permission to do so
- Processing your personal information is in Mind The Path Ltd legitimate interests
- Mind The Path Ltd needs to comply with the law

Mind The Path Ltd will retain your personal information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our policies.

If you are a resident of the European Economic Area (EEA), you have certain data protection rights. If you wish to be informed what Personal Information we hold about you and if you want it to be removed from our systems, please contact us.

Log Files

Mind The Path follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

Cookies and Web Beacons

Like any other website, Mind The Path uses 'cookies'. These cookies are used to store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.
